COMMANDERY ITEMS OF INTEREST

Commanderies numbered 1, 2 and 3 formed the Grand Commandery of Colorado March 14, 1876.

This Grand Jurisdiction has been favored by the Grand Encampment meeting at Denver in 1892, 1913, 1970 and 1994.

Sir Knight George W. Vallery (1) served the Grand Encampment as Most Eminent Grand Master, 1925-1928.

Sir Knight William H. Thornley, Jr. (1) served the Grand Encampment as Most Eminent Grand Master 1991-1994.

Colorado now has 19 active Chartered Commanderies with a membership of 731 as of June 30, 2019.



MASONIC CHRONOLOGY

Names of meetings and dates of Bodies composed exclusively of Masons.

The ordinary calendar, or vulgar era, is not generally used by Freemasons in dating their official documents. Each body has one peculiar to themselves, differing according to their various Rites.

ANCIENT CRAFT MASONS in all parts of the world add 4,000 years to the Common era, calling it *Anno Lucis*, or Year of Light: abbreviating it A.L. (This fact has a symbolic reference, not because they believe Freemasonry is, but that the principals and light of the institution are coeval with the creation) A.F.& A.M. as well as F.& A.M. Lodges hold 'Communications.'

ROYAL ARCH MASONS date from the building of the second Temple, 530 B.C. Their style is, therefore, *Anno inventionis* or A.Inv. – in the year of discovery. Royal Arch Chapters hold 'Convocations.'

CRYPTIC MASONS date from the completion of Solomon's Temple, 1,000 B.C. Their style is *Anno depositionis* or A. Dep. – in the year of Deposit. Cryptic, a.k.a. Royal and Select Councils hold 'Assemblies.'

KNIGHTS TEMPLAR date from the organization of the Order in 1118 A.D. (or C.E). Their style is, therefore, *Anno Ordinia* or A.O. – in the year of the Order. Knights Templar Commanderies hold ‘Conclaves.’

ORDER OF THE HIGH PRIESTHOOD dates from the blessing of Abraham by the High Priest Melchezadek, which occurred in 1914 B.C. Their style is *Anno Beneditions* or A.B. – in the year of the Blessing. Councils of Anointed High Priests hold ‘Convocations.’

RULES FOR MASONIC DATES

ANCIENT CRAFT MASONS – Add 4,000 years. Thus: $2017+4000 = \text{A.L. } 6017$

ROYAL ARCH MASONS – Add 530 years. Thus: $2017+530 = \text{A.Inv. } 2547$

CRYPTIC MASONS – Add 1,000 years. Thus: $2017+1000 = \text{A.Dep.}3017$.

KNIGHTS TEMPLAR – Subtract 1118 years. Thus: $2017-1118 = \text{A.O. } 899$.

ORDER OF THE HIGH PRIESTHOOD – Add 1913 years. Thus: $2017+1913 = 3930$.
